Minutes of the County Commissioners regular meeting held on February 26, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the February 20, 2024 regular meeting. It was seconded by Gary Bray. AYE: Kirk Painter and Gary Bray. ABSTAIN: Zachary Davis.

No action on a Resolution presented by Gina Desmarias in regards to asserting our sovereignty as (a governing body) to protect our citizens' freedom to decline any mandates originating from the WHO Pandemic agreement.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson informed the Board that the Statewide Emergency Management Conference next week is in Durant and he and Amanda are attending. He stated that Friday he would be attending the Active Shooter training for Law Enforcement at the hospital, Tuesday he will be traveling to Yukon for a Climates Hazard Mitigation training and Thursday is the OK First Weather re-certification class. Dale informed the Commissioners that there is a fire weather watch this week. Kim Duke reported that the Fire Board meeting was last week and that she would have the minutes for them next week. She told the Commissioners that there were some unexpected expenses last week with a truck going down. Bobby Cantu reported that he completed the safety meetings with all Grady County employees. He stated that he has a new hire Safety Orientation this week and will be attending the Pipeline Safety Training this Thursday at the Fairgrounds. He informed the Commissioners that he has sent the link of the Manual Uniform Traffic Control Devices class that will be at the Vo-tech here in Chickasha to each one of their office managers so that they could go ahead and register for this class. Bobby spoke to the Board about the new CDL requirement classes that would be in effect later in the year. He said each barn may want to send their DER person to this class. Mike McDaniels reported that he spoke with the City of Chickasha and they told him that the sink hole behind the Health Department building should be fixed by the end of the week and the sod and sprinklers are complete in front of the courthouse.

Public Comments: Will Smith come to introduce himself to the Board as the new Fire Chief of Tuttle Fire Department.

The Commissioners discussed possibly going back to do an ARPA grant to replace SCBAs (Self Contained Breathing Apparatuses') for the Grady County Fire Dept due to equipment expiring. Kim Duke stated that she would check on this and talk to Floyd and Driver to see what their recommendation would be on this matter.
