## Minutes of the County Commissioners regular meeting held on April 1, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Zachary Davis made a motion to approve the minutes of the March 18, 2024 regular meeting.

GCEMA/Fire Report/Safety Director/Superintendent: Kim Duke informed that there will be CPR classes for anyone in the County they will be held on the last Saturday of the month. There will be a fish fry at Naples Fire Station on April 7. Bobby Cantu reported that he would be doing a Safety Orientation with a new employee this next week and he is working on moving some of the records to the Health Dept. building. Mike McDaniels stated that the lights at the District Attorney's office have been installed. The dirt work will begin at Naples Fire Station this next week and the week after that they will begin on the Rush Springs Senior Citizens Center.

Public Comments: Kean Spellman wanted to say thank you to the Sheriff's office for the Disaster training that they did last week. He stated that he needed to get an agreement in place to determine jurisdiction.

Discussion with concerned Business Owners of Grady County: By Chris Kelly and Dr. Haresh Boghara with Care First Wellness Associates (formerly Southern Plains). Mr. Kelly wanted to bring to the Boards attention that the former Southern Plains Clinic had been acquired in 2021 by Dr. Boghara, since acquiring this clinic he invested millions of dollars on upgrading the space and build an ambulatory surgery center. They approached the hospital in 2022 about joining them with the surgery center but at that point it was not licensed. Having the hospital, we thought would be helpful to the center and the community since there are very few surgery centers in the surrounding areas. Negotiations started with the hospital and Mr. Spellman. On April 1, 2023 we signed an operating agreement and a promissory note where the hospital, under there subsidiary called Grady Health, agreed to buy 51% interest in the surgery center for 1.6 million dollars. Currently Grady Health has not made any payments on the promissory note they have not taken any cost or responsibility.

Dr. Boghara spoke about how to improve the access of care and how to bring in more doctors. He stated that through the years they have had a solid relationship with the hospital and would like to continue working with them for the community so our citizens do not have to leave the County.

Commissioner Painter stated that we appoint the Board from the community and they hire the administrator. He stated that if there are contracts that are outstanding then you will need to take it up with the Hospital Board, the Board of County Commissioners only handle the tax money.

Kirk Painter made a motion to approve an engagement letter from Accounting and Budgeting Services, PLLC for the 2024-2025 budget process. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Zachary Davis made a motion to table a bid for the Grady County District 1 office and parking structure, rebid for BP 5 Doors, Frames, and Hardware. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.
