## Minutes of the County Commissioners regular meeting held on April 22, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Gary Bray made a motion to approve the minutes of the April 15, 2024 regular meeting. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson reported to the Commissioners that he has received the NIMS training certificate. He stated that he would be attending the Southwest Emergency Management meeting this Wednesday and Thursday and having a Hazard Mitigation plan meeting today. Kim Duke informed the Board that the Fire Board meeting was last Tuesday in the 16<sup>th</sup> and she would be getting the minutes to them. She stated that there are monthly CPR classes that anyone from the County could attend. Bobby Cantu will be scheduling the Quarterly Safety meetings with each office and will be attending a Safety meeting at the Vo-tech. He stated that he would be working on all monthly inspections for all facilities. Mike McDaniels stated that the Emergency Warehouse lights are being installed and the Rush Springs Senior Citizen building is ready to start work on their project. Jason Knowles will be working on the awning at the Election Board.

Mike McDaniels updated the Board on Naples Fire Station project issues and concerns. He stated that the Fire Marshall has inspected the building and there are things that need to be brought up to code. Mike gave them two different solutions one was to bring the existing building up to code or move over 10 feet and build a new structure. The Board wanted to get in contact with the District Attorney's office before moving forward.
