Minutes of the County Commissioners regular meeting held on June 3, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the May 28, 2024 regular meeting. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson informed the Board that Braum's Dairy site visit is Tuesday at 9:00, they will be looking at the facility and their Emergency Action Plan. He also has a Zoom meeting with the Department of Environmental Quality and the State LEPC at 2:00. He stated that we have a chance of severe weather the next 5 days. Kim Duke stated that she would be forwarding the minutes to the Commissioners as soon as she gets them. Kim reported that the fire departments completed the pump tests for all the engines and will be starting on the hose tests for all 12 stations. Bobby Cantu stated that he would be performing two safety talks with the Sheriff's office and one with District #3. He said that he completed all inspections for fire extinguishers and fuel tanks for Grady County and took care of any issues. Bobby informed the Commissioners that he is working on the 205 Chickasha Ave. building, Suite 4, so the Court Clerk's records can be moved there. Mike McDaniels reported that the new windows for the Sheriff's office were being installed today and the new glass will be installed this week. He checked with Dynamic Fabrication and he is still waiting on the Ridge Caps for the Election Board awning.

Public Comments: Neva Ford spoke with the Commissioners about the Preserved Commissioners Proceedings, agenda item #3 on May 20, 2024 meeting. She asked about the project exceeding \$60,000.00, would like to know if the project went out for bid and was purchasing guidelines followed. She also asked what was originally on the binders, why the historical information was replaced with the current County Clerks name on it, and where are the original covers. Ms. Ford also wanted to know about the binders in Land Records, were those put out for bid, approved by the Commissioners to have replaced, what was on the previous covers, and what will be on the new covers. Commissioner Davis stated he would need to re-read the minutes, but did not have a problem with the name being placed on the preserved documents, as this was a project that the current County Clerk completed. There are other County Clerks with their names on projects they did. He mentioned that a building at District 1 is being built now, and he plans on having his name, as well as other County Commissioner names on it after completion. He also mentioned that he could only assume that the old binders looked the same and referenced a shadow box. Commissioner Davis was then asked what was on the binders that were in Land Records, he stated he never seen them before. Commissioner Bray did not know either. Commissioner Davis stated it was all public record. Commissioner Painter statecl he thought the binders were very well done, and was glad they were preserved. He would like to have seen the 1907 to current Commissioner names listed on the binders, but that was not his choice.

Mark Keeling stated that he is trying to keep up with the Sales Tax accounts. He stated that the hospital received an emergency expenditure of \$813,000.00 for insurance purposes in August 2023, he understands there are times when the county may need to help entities with emergencies,

but is the county helping everyone who is getting Sales Tax. If they are getting Sales Tax and the County still is paying for their expenses, would we not want to see how they are performing. He stated that the Fire Department Sales Tax will be coming up as a question on the ballot, and wants to know if anyone is looking at how it needs to read.

Kirk Painter made a motion to approve creating an account for funding for Emergency Active Shooter Trauma kit for school classrooms in Grady County. The account should be named Emergency School Safety. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion to approve a Service Agreement between Grady Memorial Hospital Authority and the Grady County Criminal Justice Authority wherein it is agreed that Grady Memorial Hospital will provide medical staff and clinical services to the Grady County Jail. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion to approve a quote for 2-way portable radio from Lawton Communications for Safety Director Bobby Cantu & determining which account it will be paid from. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Commissioner Painter excused himself from the meeting at 10:03 am to attend a funeral.

Gary Bray made a motion to approve Cooperative Agreement for FY 24-25 between Grady County & United States Department of Agriculture for predator & rodent control in Grady County. It was seconded by Zachary Davis. AYE: Zachary Davis and Gary Bray.

Gary Bray made a motion to approve the ASCOG REAP contract closeout certification. It was seconded by Zachary Davis. AYE: Zachary Davis and Gary Bray.

Zachary Davis made a motion of leave sharing for District 1. It was seconded by Gary Bray. AYE: Zachary Davis and Gary Bray.

Zachary Davis made a motion of depositing a check from WGN LPS Opioid Qualified Settlement Fund in the amount of \$92,051.45 into the Opioid Settlement – Walgreens M&O Account. It was seconded by Gary Bray. AYE: Zachary Davis and Gary Bray.
