## Minutes of the County Commissioners regular meeting held on July 15, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the July 8, 2024 regular meeting. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion to approve the minutes of the July 9, 2024 Joint Commissioner and Excise Board meeting. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson reported that he has a presentation tomorrow with First National Bank, they are going to donate \$5,000.00 to the Emergency School Safety Program. He also stated that they had been in contact with Arvest Bank they also planned to donate \$5,000.00 to the program. Dale informed the Board that he would be at the Southwest Emergency Management meeting this Thursday and that Amanda Wilkerson would go to the LEPC meeting on Thursday. Dale stated that the weather was going to cool off later this week. Dale asked if the Board still wanted him to attend the Fire Board meeting to discuss the Fire Sales Tax. The Board stated that they did. He stated that he had spoke to Katrina Hughes, Election Board Secretary, and that they would have to have the Resolution and Ballot ready and to her by August 21st. Kim Duke reported that there was a Fire Board meeting tomorrow night and that she planned on having her inventory update completed in the next week or two. Bobby Cantu reported that he had two District 2 employees call and schedule makeup safety meetings. Able Movers was here last week and completed moving all of the red books from the attic to the third floor. Bobby also stated that he had been out with District 3 crew last week while they were chipping and sealing to do a coverall safety check. Bobby stated that he had been weed eating around stop signs throughout the County. Mike McDaniels informed the Board of another Courthouse fall in the second-floor bathrooms. He stated that we needed to address this issue when we begin the remodel of plumbing and electric on the Courthouse. He also stated that he had been in contact with Van Dyck about the OSU building, currently they have temporary AC units there so it's cool enough to work until the new unit comes in. Mike also stated that the 205 building has been on hold as he has been busy with numerous other projects. And finally, he stated that he thought he found someone to hire as an assistant but was still looking and taking applications. Kirk Painter requested that Mike get in touch with the Chickasha Senior Citizens as they were needing help with something.

Dale Thompson stated that with the help from the State they completed the Hazard Mitigation Plan more quickly than they anticipated. He stated that County, all Municipalities, and Schools would each approve the resolution to adopt the plan.
