## Minutes of the County Commissioners regular meeting held on July 22, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the July 15, 2024 regular meeting. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson reported that they have the adoption resolutions for the Hazard Mitigation Plan sent out to all the schools and municipalities. He stated once their boards approve them, they can move forward. Dale stated that the State of Oklahoma has \$25 million left in their ARPA. He told them that around August 1st is when they are going to start working on the application process, there are some rules such as it would be a 50/50 match, the money would have to be spent by December 2026. He stated that he knew that the Board was wanting to build a new building north of the Sheriff's office and he felt like the building might qualify for this grant. The Commissioners would like to see him put this on the agenda. Kim Duke reported that the Fire Board meeting was last Tuesday. She informed the Commissioners that Mark Keeling wanted a committee formed to look at the Fire Sales Tax. The Fire Board stated that they were good with forming a committee to work on this item. Kim informed the Commissioners that the Fire Board may need to hold a special meeting to get this item on the November ballot. Bobby Cantu stated that he has been moving more records for the Court Clerk's office to 205 Chickasha Ave. He stated that he will be doing his monthly inspections this week. Mike McDaniels informed the Board that he has been renovating Suite 6 at 205 Chickasha Ave., they will also be doing more shelving in this room. The foundation repair company will be here today for the Sheriff's office basement.

New Business: Mike McDaniels brought in a quote for the Sheriff's building window tinting. The Commissioners agreed that they should get this done and approved the quote.
