Minutes of the County Commissioners regular meeting held on June 24, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the June 17, 2024 regular meeting. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson was absent. Kim Duke stated that Dale did not have anything to report. Kim Duke stated that the Fire Board meeting last week was cancelled and she was unsure if it would be rescheduled for the last week of June or in July. Bobby Cantu was absent. Mike McDaniels stated that the breezeway plumbing was repaired and concrete work finished. He also stated they were still working on the concrete work on the Emergency Management building. Kirk Painter asked if the awning at the Election Board entrance was completed. Katrina Hughes stated that it was. Mike McDaniels said that he would go inspect it after the meeting.

Public Comments: Alexandraya Brown was in attendance, she is the 2024 Grady County Miss Agriculture. She stated that she is going to be competing as the 2024 Oklahoma Miss Agriculture and asked the Commissioner's if they would like to help her with her fundraising by purchasing an add. Kirk Painter stated that they could not purchase it as the County with County money but that individually they could. Zachary Davis asked how they could go about getting an add. Miss Brown stated that she could email her.

Deidre Koehler was present and had a question for Commissioner Davis. She asked if it was true that Commissioner Davis had a lawsuit against the County. Commissioner Davis stated that was correct. Mrs. Koehler then asked what the lawsuit was for. Commissioner Davis said that it was a wrongful termination lawsuit on the former Commissioner.

New Business: Kirk Painter stated that there had been an incident at the Grady County rodeo this past weekend, he wanted to thank the Sheriff's department on the tremendous job the deputies and reserve deputies did. He also stated that the City of Chickasha responded to assist the County. He stated this is how it should work with the County and City working with each other.

Zachary Davis made a motion to approve draw request from the Grady Memorial Hospital's sales tax accounts held with First National Bank:

It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Katrina Hughes, Election Board Secretary, presented the Board with an update and cost estimate for the upcoming August election. She stated that after the primary election there was only County candidates on the ballot, therefore the County would be responsible for the funding of the election. She also explained that the beginning half of her budget would not be enough to cover the August and November elections, she will be going to the Excise Board to request a temporary transfer but wanted to get the Commissioner's approval first. The total estimated cost of the August election for the County is \$15,835.00. Kirk Painter made a motion to approve the \$15,835.00 cost of the August election. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Zachary Davis made a motion to enter into executive session for the purpose of discussing the employment, hiring, appointment, promotion, demotion, disciplining or resignation of any individual salaried public officer or employee. Specifically, Jonas Clothier; Title 25, Okla Statues § 307-B1. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion return to regular session. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Zachary Davis made a motion to approve terminating Jonas Clothier as a construction general laborer for Grady County, effective immediately. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Gary Bray stated that when he first came into office the road money was re-divided as follows: District 1 - 32%, District 2 - 32%, and District 3 - 36%. At that time, he was unaware of how many road miles that District 3 had. Commissioner Bray stated that out of the 1,492 total road miles in Grady County each district has the following: District 1 - 343.67, District 2 - 510.58, and District 3 - 638.18. Which break down as follows: Each district has the following miles of asphalt roads: District 1 - 155, District 2 – 215, and District 3 – 410. The following miles of gravel roads: District 1 – 184, District 2 – 277, and District 3 – 205. District 3 begins at the Grady – Stephens County line and ends in Chickasha on Florida Avenue where the tag agency is. District 3 has 294 more miles than District 1 and 194 more miles than District 2. District 3 has 255 more asphalt roads than District 1 and 194 more asphalt roads than District 2. Commissioner Bray stated that he received a print out from ODOT on June 19th that gave an estimate of these statistics. Commissioner Bray had his road Foreman grid out his district and check on the road miles. They found that their figure was within 6 miles of what ODOT had given them. Commissioner Bray said that he felt that the money should be re-divided. Zachary Davis asked how he thought it should be divided. Commissioner Bray stated he felt it should be based off the road miles and came up with the following division: District 1 - 23%, District 2 - 34%, and District 3 - 43%. Commissioner Bray asked if this division was fair. Commissioner Davis stated that it was not, he stated that his roads wear out faster as he has a more concentrated population in a smaller area. Commissioner Davis stated that he wanted to make his position very clear. As a representative of District 1 citizens, he was not interested in giving up one penny. Commissioner Davis stated that he

agreed to give up 1% when he came into office because he felt like District 2 deserved more than the 30%, they were getting. Commissioner Davis stated that the money and population had not changed so why did they need to re-divide the money again. Commissioner Davis stated that unless they hired an engineering firm to conduct studies on the cost of each district's road repair and how often they need repaired, then any division they came up with would only be an opinion. Commissioner Davis then asked who put the item on the agenda. Commissioner Bray stated his secretary, Cavin Newman put it on the agenda. Commissioner Davis stated that currently District 3 has \$5.7 million dollars unencumbered in his accounts, why would he need to take money from District 1 citizens? Commissioner Bray stated that he is managing his money, and currently has 40 miles of road tore up ready to overlay and the cost to overlay is very expensive. Commissioner Davis asked why he was not chipping and sealing instead. Commissioner Bray replied they were chipping and sealing roads as well. Commissioner Davis stated that they have 2,500 to 3,500 cars traveling per day traveling their roads with one road having 7,000 cars a day. Commissioner Davis asked if Commissioner Bray had any data of how many cars travel his roads per day. Commissioner Bray stated that he did not. Commissioner Davis stated that the roads he maintains are unincorporated roads and therefore get more wear and tear on them. Commissioner Bray stated that his roads get traveled a lot as well and stated the Cox City area has increased in size. Commissioner Davis asked Commissioner Painter and Commissioner Bray if they discussed this agenda item outside of the meeting. Commissioner Painter and Commissioner Bray denied this happened. Commissioner Davis stated that he has heard about this re-division of money since early April, he stated that he heard it from both District 2 and District 3 employees. All of which have stated Gary Bray and Kirk Painter are talking about re-dividing the money, and this has not been an agenda item this year. Commissioner Davis continued to say that he even heard it was going to happen after the June 18th election. Last week he was told it was going to be added to the June 24th agenda. Commissioner Davis stated that in April, he himself overheard Commissioner Painter state "Zac's not going to like our next stunt, we are going to re-divide the money after the election." Commissioner Davis said that he was not sure who Commissioner Painter was talking to as he was standing around the corner but it was a direct quote. Commissioner Davis then stated he has had citizens tell him that Commissioner Painter & Commissioner Bray have been seen eating together at several places. Commissioner Davis stated that he seen them at ACCO together at tables by their selves with no one around. Commissioner Davis has also personally seen them together at food establishments. Commissioner Davis asked again if they discussed this outside of this meeting. Both Commissioner Painter and Commissioner Bray again denied any conversations outside of the meeting regarding County business. Gary Bray stated he has spoken to his employees about this item, but not Commissioner Painter. Commissioner Painter stated that it was not a violation for them to eat together if they did not discuss County business. Commissioner Davis asked how they explain the fact that he had several people tell him the exact same thing about the division of the road money and even gave him the date a week ago, and now it is happening exactly as he was told. Commissioner Davis referred to the fact that Commissioner Painter was overheard stating it would happen after the election, and Commissioner Bray had it put on the agenda after the election. Commissioner Davis asked how it was possible if it was not discussed outside of the meeting. Commissioner Davis stated that the citizens of Grady County deserved to know the answer to this, however; the answer was simple, it was a violation of the Open Meetings Act. Commissioner Davis stated that Commissioner Painter and Commissioner Bray continually make a mockery of the Open Meetings Act, and there have been many instances since January that has made it clear the agenda items were rehearsed between the two of them. Commissioner Davis stated this is dangerous for our County, two Commissioners are making decisions for the 60,000 citizens in our County behind closed doors. Charles Sifers, Assistant District Attorney asked if he could have the floor. Mr. Sifers stated that an allegation of a crime was being committed,

and there has been enough evidence presented to do an investigation. Mr. Sifers continued to say that the agenda item to change the division of road money needed to be set aside until the investigation is over. Mr. Sifers stated that there might be a need to address the division of road money, but at this time he urged the Board as their legal-council to take no action. Commissioner Painter stated that two Commissioners can meet outside of an open meeting if no County business is discussed. Mr. Sifers stated that perception is reality, he stated that he has already advised Commissioner Painter in the past not to meet outside of an open meeting, even if it is just for lunch. Mr. Sifers said however, your statement is technically correct, his legal advice is to not do it. Commissioner Painter stated that Commissioner Bray and himself were being discriminated against for being friends. Mr. Sifers stated that as your lawyer, I just advised you not to do it. Commissioner Painter stated that he has never seen the figures presented today by Commissioner Bray, when he came into office himself, he was getting the least amount. For years the other two Commissioner's at the time would vote to the division that favored their districts. Commissioner Painter was told that they would not change the division to help District 2. Mr. Sifers stated again, that the Board needed to take no action.

Kirk Painter stated no action on the division of road money for Districts 1, 2, and 3.

Zachary Davis made a motion to table the agenda item for altering a 2005 Resolution that states all roads within Grady County being additions and subdivision of tracts of land shall not be accepted by County Commissioners to maintain unless roads are constructed to a minimum standard set forth (see resolution). It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

John Nicholas stated that this was currently a 2-way stop. Kirk Painter informed the Board this would make the intersection safer and they have received complaint calls about the intersection as well. Kirk Painter made a motion to approve making a 4-way stop at the intersection of County Street 2802 and County Road 1310, located within District 2. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Zachary Davis made a motion to approve the annual Hyper-Reach Emergency notification system; with Sheriff's E-911 account paying \$7,000.00 and General Government paying the remaining \$7,000.00 for a total of \$14,000.00. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Zachary Davis made a motion to approve the annual Spatial Data Research, E-cop service; with Sheriff's E-911 account paying \$1,300.00, General Government paying \$1,300.00, Highway Rural Fire paying \$1,600.00, and Grady County Fire paying \$1,000 for a total of \$5,200.00. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter stated that he has not had an opportunity to review these agreements and would like to table them all for review. Commissioner Painter stated that he thought the Board should have all the information for review before the meeting. Kealee Romero asked if they would like to begin receiving the information for the agenda before the meetings, that the County Clerk's office did it in the past and it was never picked up, so it was stopped.

Kirk Painter made a motion to table the FY 2024-2025 Standley Systems, LC - lease agreement for the Sheriff. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion to table the following Standley Systems, LLC - maintenance agreement for the fiscal year 2024-2025: County Clerk, Election Board, Sheriff, and Sheriff-Dispatch. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion to table the following Kellpro software and service agreement for the fiscal year 2024-2025: County Clerk, Election Board, Emergency Management, Grady County, District 1, and District 2. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter stated that he would like to see other quotes for the Firewall. Kealee Romero stated that for someone else to take care of the Firewall they would have to convert the entire system. Commissioner Painter stated that he would still like to see the other quotes. Kirk Painter made a motion to table the FY 2024-2025 Industry Systems Firewall renewal agreement for Grady County. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Zachary Davis made a motion to approve the FY 2024-2025 Alcom service agreement for District 1. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion to approve the Declaration of Surplus for the Treasurer's Office, in accordance with 19 O.S. Sec. 339 & 421 through 421.2 for the following:
