

Minutes of the County Commissioners regular meeting held on October 15, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Karen White, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Karen White, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson informed the Board that the Emergency Management would be participating in the Great American Shake Out Earthquake training on the 17th of October. Dale stated that the LEPC meeting was changed to October 24th at the Tech Center. Kim Duke stated that the Fire Board meeting was tonight and the agenda would get sent to the Commissioners today. Mike McDaniels reported that the backflow plumbing valves have been replaced in the Emergency Management building, the parking blocks have been completed in front of the Sheriff's office, and he would be working at district 2 this next week.
