The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Karen White, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Karen White, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

GCEMA/Fire Report/Safety Director/Superintendent: Bobby Cantu reported that the monthly inspections for all walk-through facilities have been completed. He stated that there were some concerns and they have been reported to the appropriate department. Bobby informed the Board that has sent each DER on the options for CDL training at the ACCO conference. Bobby said he completed the Fuel Leak Tank Monthly inspections and Quarterly Safety Talks for most of the offices. A-1 National Summit Fire and Security finished are installing the sprinkler system at 205 Chickasha Ave, Suite 7. Mike McDaniels reported that the tile in the Security Vestibule is complete and the Emergency Management building will be getting more concrete work done after the weather clears.

Audience Participation: Rodney Young was in attendance and spoke to the Board on how he feels about the fire tax. He stated that the tax should not be put back into effect because there were steps that were not taken that he felt were very important in order to move forward.
