## Minutes of the County Commissioners regular meeting held on October 28, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Gary Bray made a motion to approve the minutes of the October 21, 2024 regular meeting. It was seconded by Zachary Davis. AYE: Zachary Davis and Gary Bray. ABSTAIN: Kirk Painter

GCEMA/Fire Report/Safety Director/Superintendent: Kim Duke informed the Commissioners about the Task Force that was out this weekend at the Meers Rush Fires. Kim stated that the Fire Chiefs have voted to declare today and tomorrow as "WAR" (We all Respond) Days. Bobby Cantu reported that he would be conducting the monthly inspections and the final quarterly safety meetings for the year. He stated that NACO official flag box was emptied at the Emergency Management building and there were 47 flags taken for retirement. Mike McDaniels stated that there were several sewer issues last week and only has one more repair before they will all be fixed. He has also completed the sky lights repair at District #2.

Audience Participation: Rodney Young was wanting copies of the following documents from the Friend fire station meeting on October 19, 2024: minutes, the vote that was taken, and the roster on who was there.

New Business: Mike McDaniels stated that there was a problem with the Election Board air conditioner and they are needing it fixed as soon as possible due to the upcoming election so they have called Melton's Heat & Air. The Board agreed that they need to move forward on this issue.

Commissioner Painter stated that with all the issues the City of Chickasha is having with the water lines, he wanted to let everyone know we would not be closing the courthouse for these issues again. Commissioner Davis stated that he is the Chairman of the Board and that will be his decision.

Gary Bray made a motion to approve contract between A-1 National Fire Co. and Grady County for the fire sprinkler deficiency repairs on the Health Department Building. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Eric Ashbey, Fire Chief for Friend Fire Station addressed the Board on the reason the fire station felt they needed to remove Rodney Young and appoint Mr. Samaniego to be the next Friend Fire Station Board member. He stated that the Fire Station voted for Mr. Young to be removed because he has a sign to vote "no" to the Fire Tax on his property, it was a unanimous vote to remove him. Commissioner Bray wanted Charles Sifers, A.D.A. to give his opinion on this. Mr. Sifers stated his opinion would be that Mr. Young could only be removed for due cause. He stated he would suggest that the Board take no action on the two agenda items #8 & #9 because the Board would be exposing themselves if there is no cause in Mr. Young's term to remove him.

No action to remove Rodney Young as the Friend Representative to the Grady County Fire Board.

No action to appoint Tony Samaniego as the Friend Representative to the Grady County Fire Board for a term of 5 years.

Zachary Davis made a motion to reappoint of Tamara Holland to the McClain-Grady County EMS District #1, term will expire October 31, 2029. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Mark Lykes with Camino Resources was in attendance to answer any questions about the process in which to lease the counties oil leases.

Zachary Davis made a motion to table a resolution authorizing execution of an oil and gas lease between Grady County and Camino Natural Resources, LLC. The Commissioners would like more information on how this process works. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Zachary Davis made a motion to table a resolution approving execution of an oil and gas lease between Grady County and Camino Natural Resources, LLC. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Gary Bray made a motion to awarding a quoted bid for a new mini split for new office at the Sheriff's building to the lowest bid, Melton's Heat and Air in the amount of \$6,094.60. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Gary Bray made a motion to rescind the bid approved on October 21, 2024 for Soil Binding Agent for Grady County District 3; as this item is a sole source product from Share Corp. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Gary Bray made a motion to accept a sole source letter as an exemption to the bidding process for District 3, from Share Corp for Silica Soil Binder. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Acknowledgement of the Requisitioning Officer for Public Health name change from Martha Hames to Martha Campbell
