Minutes of the County Commissioners regular meeting held on December 16, 2024

The Board of the Grady County Commissioners met on this day for a regular meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Gary Bray made a motion to approve the minutes of the December 9, 2024 regular meeting. It was seconded by Zachary Davis. AYE: Zachary Davis and Gary Bray. ABSTAIN: Kirk Painter.

Chris Dragg and Sassan Moghadan addressed the Board of County Commissioners in reference to Chilsom Trail property taxes and evaluation. They stated they met with the Assessor and they feel like there are discrepancies on their evaluations of their taxes and are questioning what the state law is allowing them to apply. They spoke to the Board about the TIFF and how they feel that the evaluation is not in compliance. The Board directed them to the Assessor's office and Commissioner Painter told them they could get on the agenda for the Tax Roll Corrections Board.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson informed the Board they are waiting on the city to inspect the plumbing before they move forward with finishing the project. He stated that the passport office has completed 638 passports since January 1. Kim Duke stated that the Fire Board meeting is Tuesday night and they will be starting their countywide training after the first of the year. Bobby Cantu reported that there were 3 injuries last week in the county. He stated that he will be conducting all the monthly inspections this next week. Mike McDaniels informed the Commissioners that the old cast iron had to be torn out of the Emergency Management building and that is what has held up the work. He stated that he would be starting on the Sheriff's warehouse this next week.

New Business: Commissioner Painter would like to see the parking space at the Election Board become a handicap parking space and not an employee space.

Kirk Painter made a motion to approve the following draw request from the Grady Memorial Hospital's sales tax accounts held with First National Bank: Teleflex LLC - Surgical Instrument (retractor) \$3,500.00; Fusion Sign & Design - Outdoor Illuminated Signs (2) - \$23,372.38. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kean Spellman gave the Commissioner's an update on the progress of Grady Memorial Hospital's roof replacement. Mr. Spellman stated that the hospital hired an engineer to survey the amount of damage they had on their roof and the engineer found significant amount of damage and will now be replacing the roofs of 4 buildings. Mr. Spellman wanted the Board to know that there is a program that all municipalities and schools are using called TOPS and it is a group purchasing program. He stated that it saved them a lot of time on getting the roof taken care of in a timely manner and he felt that the County could benefit from this program.

Mr. Spellman addressed the Board and asked them for help with a Women's Primary Care Physician. He stated that they only have one female physician and would like to see the hospital have another physician. This would be for a 3-year commitment signing bonus and 3 months of her pay and her malpractice insurance. It would be contingent if she decides to come. Commissioner Davis stated

that he did not feel like it was the Board of County Commissioners issue to recruit doctors for the hospital and with the money that the hospital gets from Sales Tax, Use Tax, and the ARPA money they should be able to afford to do this.

No action on the request from Grady Memorial Hospital for County assistance with funding a Physician recruitment and retention of a Women's Primary Care Physician in the amount of \$125,975.00.

Zachary Davis made a motion to approve a Planned Maintenance agreement between Clifford Power Systems and Grady County Emergency Management. It was seconded by Kirk Painter. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion to approve a quote from AED Superstore for two AED machines in the amount of \$3,118.00. It was seconded by Zachary Davis. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Zachary Davis made a motion to approve an amended award of American Rescue Plan Act Funds and Beneficiary Award Agreement Between Grady County, Oklahoma, and Chickasha Soup Kitchen. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

Kirk Painter made a motion to approve the tabled item for distribution of the residual funds of the Trust Estate of The Grady County Home Finance Authority in the amount of \$7,504.78 to the Grady County Commissioners.
