## Minutes of the County Commissioners Regular meeting held on January 6, 2025

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was called to order and roll call: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was opened with the "Pledge of Allegiance"

Ruth Bingham made a motion to approve the appointment of Gary Bray as the Chairman, Zachary Davis as the Vice-Chairman, and Ruth Bingham as the member for the Grady County Board of Commissioners for the Calendar Year 2025. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Zachary Davis made a motion to approve the minutes of the December 30, 2024 meeting. It was seconded by Gary Bray. AYE: Gary Bray and Zachary Davis. ABSTAIN: Ruth Bingham

Mr. Eric Smith presented the Commissioners with a re-plat of Winter Creek Part 8. Commissioner Bingham asked if he had all the signatures. Mr. Smith said he did not get every signature and left to go finish getting all the signatures and never returned to the meeting.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson reported that construction in the Emergency Management building is complete; therefore, they started scheduling passports again. Dale stated that the LEPC meeting will be this month and they are preparing the School Safety Trauma kits for all the schools in Grady County. Kim Duke informed the Board that there was a structure fire in Farwell that had a great turnout of volunteer firemen. Kim stated that the Farwell Christmas party was last Saturday night. Bobby Cantu reported that he is still working on the Disaster Recovery Plans. He stated that he would soon be scheduling the first quarterly safety meetings for 2025 and he will be at District #2 this week conducting the FMCSA annual queries on all CDL drivers. Mike McDaniels stated that the Emergency Management building has been completed and the handrails are all up outside as well. He informed the Commissioners that he was starting a project on the 2<sup>nd</sup> floor this next week. Commissioner Davis stated that he made an executive decision last week to change all the door locks on the Courthouse because someone would not return a key and as a safety pre-caution, he authorized the re-keying of the Courthouse. Commissioner Bingham stated that she wanted everyone to know that the back door is not an entry to the Courthouse. Vicki Elliott asked about the vendors, and Commissioner Bingham responded that they could only if they were with maintenance personnel.

New Business: Commissioner Bingham stated that she had been approached about closing the Courthouse for the funeral of President Carter, some federal buildings were closing but Grady County will not be closing. Commissioner Bingham asked the Board if there was a way for the County to help the Soup Kitchen with taking care of some of their needs with the homeless during this cold weather. It was being discussed when the Sheriff and District #3 both said they had some donated water that they would take down there. She stated that we should find out if there is more that we can do in the future.

Acknowledgement of Sydney Richardson as the Grady County Purchasing Agent.

Liz Taylor came to the meeting to explain the reason behind why she wanted to follow the OSU holiday schedule instead of the County schedule. She stated that people cannot get questions answered or get soil samples because their head office is shut down for the holidays and they are still open. They would like to be able to stay open on Presidents Day, Columbus/Indigenous Day, and Veterans Day because these days their head office is also open. She stated that it makes more sense to be open the same day as their head office. The Commissioners agreed with Ms. Taylor.

Zachary Davis made a motion to approve the Grady County OSU Extension Office to use the OSU Holiday Schedule. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Ruth Bingham made a motion to approve of removing Kirk Painter, Karen White, and Jon Diehl as Requisitioning Officer and adding Ruth Bingham and John Nicholas to the following District 2 Requisitioning departments: District #2, CIRB-MV District 2, FEMA Highway Projects District 2, Highway District 2, and Restricted Highway District 2. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Gary Bray made a motion to table the annual update of all requisition and receiving officers specified by requisitioning departments. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

There was discussion on who would be over the DA's building, Emergency Management/ Election Board building, OSU Extension building and the Courthouse. Commissioner Bingham stated that she felt that since the district #2 barn was open 5 days a week, then she would like to be over the all of these facilities.

Gary Bray made a motion to approve Commissioner Bingham to oversee the DA's building, Emergency Management/Election Board building, OSU Extension building, and the Courthouse. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Recognition of the new Chairman to the Tax Toll Correction Board, is the new Chairman of the Board of County Commissioners, for the calendar year 2025.

The Commissioners discussed the various Board's that they set on and which Board members may want to sit on each.

Zachary Davis made a motion to approve of a resolution approving interlocal cooperative agreement, appointing county's representative to CED Board of Directors, and authorizing representative to sign interlocal cooperative agreement. Gary Bray made a motion to approve of EMPG grant for FY 2024-25 for Oklahoma Emergency Management Performance Grant for \$30,000.00. It was seconded by Zachary Davis. Zachary Davis made a motion to approve the Grady County Fire Board to find a new representative to appoint to fill the Bradley representative to the Grady County Fire Board. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Commissioner Bingham wanted to thank District 1 for coming to help with inventory. John Nicholas stated that there was a pole saw and a power supply that they could not locate. Commissioner Davis stated that he would like to put on record that there were allegations last week that John Nicholas had something to do with the inventory being incorrect and he would like it on record that John was not responsible for the inventory for 4 months because he was not employed at District 2 during that time.
