

Minutes of the County Commissioners regular meeting held on January 27, 2025

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was called to order and roll call: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was opened with the "Pledge of Allegiance"

Acknowledgement of the Grady County Assessor's letter of resignation, to take effect on January 31, 2025.

Ruth Bingham made a motion to appoint Cynthia Gelnar to complete the present term of office of the Assessor for Grady County, thereby filling the vacancy caused by the February 1, 2025 resignation of the current Assessor. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Swearing in of the newly appointed Assessor, Cynthia Gelnar by Judge Young for an effective date of February 1, 2025.

Zachary Davis made a motion to approve the minutes of the January 21, 2025 meeting. It was seconded by Ruth Bingham. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson informed the Board that he will be attending state training on Friday. He stated that there is rain predicted for this week. Kim Duke reported that the CPR classes last Saturday were cancelled. She stated that they have had 17 people sign up for the County purchasing class. Bobby Cantu informed the Board that he conducted a Safety meeting with Emergency Management and Kim Duke this morning and he would be conducting the monthly inspections this week. Bobby stated that he will be facilitating new hire orientations for two employees for District #2 and he is working on the Injuries and Illnesses Survey for the Calendar year 2024.

Audience Participation: Commissioner Bingham wanted to introduce Bill Flores with Leadership Chickasha and Community Alliance, as well as two County roadworkers from District #2, Mr. J. R. Morris and Justin Maley.

New Business: Sheriff Gary Boggess spoke to the Board about looking at purchasing a new x-ray machine for the Security Vestibule. The Sheriff stated that he would get more information on what the costs would be for a new one.

Ruth Bingham made a motion to approve Debbie DeSilver and Kathryn Terry to research County records to get an accurate list of Officials of Grady County from statehood forward. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Mr. Lykes with Camino updated the Board on the property that Camino would like to see the County lease. He stated that oil and gas leases can be auctioned or a sealed bid process. Commissioner Bingham stated this might be a conflict of interest for Camino to hold the auction or bid and then bid on the lease. Mr. Lykes stated that Camino does the research and then they offer their services but anyone could present this information and offer a bid.

Ruth Bingham made a motion to table the oil and gas lease offers with Camino to find out more information. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Commissioner Bingham stated she spoke with Gloria Bowles with Life Skills and their shelter has been set up for overnight stay if it is 25 degrees or below. She stated they took them cans of soup and water for now. Commissioner Bingham spoke with Steve Taylor from the Soup Kitchen and their day shelter is open if it is 32 degrees or less. The Soup Kitchen likes to provide coffee and individual wrapped snacks. There are no parameters right now for the summer but would address later. They will be given 100.00 a day of food as needed, the shelters that have a commercial kitchen is how the County will determine who will be given food and drinks for now. Sheriff Boggess stated he had more donated water if they needed it.

Gary Bray made a motion to table the item for the Charity account and setting the parameters helping the homeless with food and water during extreme weather conditions. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

The Commissioners discussed the differences in the employees who are receiving allowances. Commissioner Bingham stated that this is tax payer money and she is wanting to make sure guidelines are set to how a person receives a county phone.

Ruth Bingham made a motion to approve setting qualification guidelines as follows: driving a county vehicle and 24-hour call for an employee to receive phone allowance. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Zachary Davis made a motion to approve a tabled item for setting a standard amount for phone allowance. Grady County employees that have phones already and the amount that they are getting will be grandfathered in and anyone who is allowed to get a phone allowance from this point forward would get a \$40.00 a month allowance. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.
