## Minutes of the County Commissioners regular meeting held on March 17, 2025

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was called to order and roll call: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was opened with the "Pledge of Allegiance"

Zachary Davis made a motion to approve the minutes from March 10, 2025 Commissioner's meeting. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Mr. Patrick Brown asked for the Board's help on how to solve an issue with section line 2850 and 1330 and easement issue that has been land locked. He stated that he would like to build the approach since the County does not want to open and maintain a road to this property and would he need to fill out a Tinhorn Permit Application. The Commissioners told him that these matters are best handled individually and since this property was in District 2, he would need to speak with Commissioner Bingham and her foreman. Commissioner Bingham asked him to come to the barn and they would see how they could resolve this issue and then add it back to the agenda if necessary. The Commissioners took no action on this item.

Thomas Smith and Kaleb Smith, with Pro Active Security Solution, presented safety and security enhancements for all Grady County properties. Thomas Smith stated that they do a lot of work with the schools but have decided to broaden their clientele with Counties. Kaleb Smith gave a presentation on the ballistics products their company offers as well as other products that could be useful to the County.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson informed the Board that there is a Red Flag warning Monday and Tuesday. He informed the Commissioners that there were no structures lost in the fire on Friday in Grady County. The Commissioners asked Dale to investigate instating a burn ban for Grady County. Dale said he would look at the criteria, but as of right now the drought monitor does not have Grady County very high. He stated that the Emergency Management activated the EOC at a level 2 on Friday. Kim Duke reported that they had 18 fire calls on Friday. They helped with fires at Cement and Lindsey, took 11 trucks to Little Axe on Saturday, and there are 3 fire trucks at Leedey today. She stated that there were 10 to 12 volunteers that took off from their regular jobs to watch fires on Friday. She stated that the firefighters are to be commended for the hard work and long hours they have endured over the last few days. The Commissioners agreed that all departments Emergency Management, Fire Departments, and 911 Dispatch should be commended on everything they did to protect Grady County. Commissioner Bray asked Charles Sifers A.D.A. if other counties throughout the state can request aid. Mr. Sifers answered yes. Dale Thompson stated with State Mutual Aid Compact through the State and County. Dale wanted to remind everyone to document everything because it could qualify for FEMA Fire Management Assistant Grants (FMAGS) and we could be reimbursed for repairs and fuel, if we meet the criteria. Bobby Cantu reported that he completed a Safety meeting this morning with District #3 and will be conducting a Safety Orientation for District #3 new employee. He stated that, he along with 4 other County employees have completed the class 4 Power Industrial Truck Training with the Vo-tech. He informed the Commissioners he would be at the ACCO Safety Conference this Wednesday and Thursday. Mike McDaniels stated that he walked around with the architects this week to talk to Officials and take measurements of the Courthouse for the renovation project of the Courthouse. The Court Clerk's carpet was completed this last weekend.

Commissioner Bingham wanted to reiterate that we hired Mike McDaniels to be over any construction within the County and we need to utilize him in this capacity. She stated every project should run through him.

New Business: Commissioner Bingham stated that Mike McDaniels took the CMS Willowbrook team to the Sheriff's office to look at a wall that the Sheriff wanted taken down. The CMS Willowbrook team suggested that they have a structural engineer look at this due to it possibly being a load bearing wall.

No action to approve to accept a bid from Dexter Blakes for the following properties: parcel ID# C001-00-114-001-0-000-00, TID# 22206, in the amount of \$473.70; parcel ID# C001-00-114-002-0-000-00, TID# 22207, in the amount of \$530.00.

No action to approve the purchase of the property bordering the Pioneer Fire Station to the North. Proposed purchase price \$53,000.00.

Zachary Davis made a motion to approve awarding a tabled bid for a fenced parking lot for Grady County to Post Oak Construction for \$49,920.00, ASG Electric for \$19,500.00, and Michael Coffey for \$66,416.00. (See other Bids) It was seconded by Ruth Bingham. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Zachary Davis made a motion to approve Proposed Executive Session Pursuant to Title 25 Okla. Statute, § 307(B)(3) ("Executive sessions of public bodies will be permitted only for the purpose of . . . 3) Discussing the purchase or appraisal of real property . . . ."). It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Gary Bray made a motion to approve to return to Regular Session. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Ruth Bingham made a motion to approve to purchase the land on which the district #2 barn is located to the Industrial Authority for \$125,000.00. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

Commissioner Bingham stated that the employee's driving vehicles back and forth to work should be keeping track of their mileage for the fringe benefit on their W-2, except for the Sheriff deputies. She also emphasized that no family members should be riding along with anyone who is driving a vehicle, it is a liability to the County.
