## Minutes of the County Commissioners regular meeting held on March 3, 2025

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was called to order and roll call: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was opened with the "Pledge of Allegiance"

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson informed the Board that he attended a Pipeline Safety meeting last week. He stated that he spoke with the County Fire Chiefs and they all agreed that they would like to see a burn ban for the county instated; however, we do not meet the criteria for a burn ban. He presented the Board a drought monitor map. Dale stated that he would be monitoring the severe weather situation tonight. Kim Duke stated that all fire departments are making repairs to be ready for the fire season. She informed the Board that there is a Fre Chiefs meeting at 6:00 tonight. Bobby Cantu reported that the County had one reportable motor vehicle accident last week and this morning there was test of the intercom system in the courthouse. Bobby stated that he would be conducting District 1 safety meeting on Tuesday morning and a Safety Orientation for one of District 2 new employees. Bobby told the Board that there is training that was sent to him by Dale Frech, it has to do with Drug/Alcohol testing and FMLA training. Mike McDaniels stated that they received the forklift recently purchased last week for the courthouse and the Emergency Management new sidewalk was completed but has some problems. He also told the Board he would like to have them come back and look and see if there is anything else we can do to correct the problem.

Audience Participation: Bill Flores with Earthly Dwellings spoke to the Board by thanking them for all the good things they do for the County. He likes working with the Community Alianice groups, and tries to find various ways to help the community.

New Business: A request for an Indigent Assistance came in on Friday therefore the Commissioners voted to go ahead with the request. Zachary Davis made a motion to approve the Grady County Indigent Assistance request for Kathleen Georgette Herring. It was seconded by Ruth Bingham. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

He stated that every deputy is working out according to his policy. The Commissioners would like to send the Gym policy for the County and the Sheriff policy to ACCO for some clarification issues.
