Minutes of the County Commissioners regular meeting held on April 21, 2025

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was called to order and roll call: Gary Bray, Zachary Davis, and Ruth Bingham.

The meeting was opened with the "Pledge of Allegiance"

Bobby Cantu stated that the County had one reportable injury, he will be conducting monthly inspections and the Sheriff's safety meeting. Mike McDaniels stated that he finished the OSU bathroom conversion, the Architect will be coming to talk to Officials tomorrow, and the electrical work will begin at District 3 this week.
