Presentation from Tammy Watts representing Oklahoma Home and Community Education, as well as signing of Proclamation. Tammy Watts stated that OHCE is made up of 7 groups within the county and these groups together have clocked over 13,000 volunteer hours. Some of their projects include luncheons for the veterans and presentations of quilts for them, donations to local community groups, workshops on cookie making, canning, barn quilts and homemade pie crust. They have youth baking classes in the summer, which the parents of the youth reported that these students were making healthier food choices. The OHCE meetings each month consist of teaching lessons to engage in lifelong learning and to help serve and strengthen the community.

Zachary Davis made a motion to approve the State of Emergency for Grady County due to storms, flooding, and heavy rainfall. Dale Thompson stated that he would send the Resolution to the State. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

GCEMA/Fire Report/Safety Director/Superintendent: Dale Thompson reported that the County is in a flood watch and he will be briefed by the state at 10:00. He stated that there had been 7 roads reported closed, and 5 additional counties could be added to the 3 already on the Governors State of Emergency. Bobby Cantu informed the Board that there was one reportable vehicle accident last week. He stated that he conducted the second Quarterly Safety meeting with the Treasurer's office and the Election Board, and will be meeting with the Court Clerk, Commissioner Secretary, maintenance, and the County Clerk. He gave the Board some areas that he did some work on stop signs and commended the Commissioner's road-crew for all the work they have done due to flooding.

Mike McDaniels reported that he has several work orders this past week that have been completed and several more that he is working on estimates. Mike let Commissioner Bray know that PSO is ready to start on the electric line, but will have to see what the weather does.

New Business: Commissioner Bingham had been sent some herbicide info and was going to be passing that on to the maintenance staff.

Acknowledgement of Greg Elliott's resignation to the Grady Memorial Hospital Authority Board of Trustees as the Grady County District #2 representative.

Ruth Bingham made a motion to approve the appointment of Brad Wilkerson, to the Grady Memorial Hospital Authority Board of Trustees representing Grady County District 2. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and Ruth Bingham.

The Commissioners recognized First National Bank & Trust Co. for their generous donation of a former bank branch real property and premises located in Rush Springs, Oklahoma, and within Grady County District 3, to Grady Memorial Hospital Authority.

Commissioner Bingham asked her foreman John Nicholas to update the Commissioners on County Road 1322 west of County Line. Mr. Nicholas stated that a pond dam gave way and there were 8 to 10 homes that were affected, a homeowner gave permission to put in a temporary road to be able to give the homeowners an exit route.

Gary Bray made a motion to approve a bid request for typesetting, printing and delivery of ballot proofs, optech ballot cards and sample ballots for all ballot orders placed during the period from July 1, 2025 to June 30, 2026 for the Grady County Election Board.
